- Peter Delguidice- Provided of brief overview of his project to build a 8,880 sq. ft. metal building (garage) on his property located at 78850 Darby Road, Bermuda Dunes, CA 92203. This was just an informational item that would be brought forward potentially the next meeting. The Community Council acknowledged its willingness to meet in February if the project is ready to move forward.
- Phillip Bettencourt- Spoke about his concern regarding the condition of the intersection of Jefferson I-10. It is the gateway, Bermuda Dunes, Humana Tournament, Coachella Fest and The Polo fields. He provided a letter to the Supervisor Benoit's office suggest that city and county officials need to be more accountable for this area.
- Joe Contaoi- Riverside County Waste Management Department representative-Stated this department is now in charge of Community Cleanup events and he oversees illegal dumping on County roads.
- Cheryl Isen- Stated that she had some concern about the new format of the minutes. She also mentioned that she sent a letter to Joe Pradetto and suggested that she would like to have the CHP and Animal Control added to the agenda's staff report items. Mrs. Isen had some concern about large jets flying over Bermuda Dunes to approach Palm Springs Airport and water run off issues near the Santa Fe Homes

    - Reported Crime Stats for 2013- Total 471 Part 1 Crimes- A reduction of 21.5%
    - Met with Supervisor Benoit and the Supervisor shared his concern about metal theft in the region.
    - Slowly building up Sheriff's department up again but our region is last on the list to add deputies.

Code Enforcement has a current open case on Glass street regarding a abandon home.
