4. Riverside County 4th District Supervisor John J. Benoit

- A. Reviewed fiscal condition of the county, which is primarily funded by property taxes
- B. Discussed progress of new facilities being built in Indio associated with the East County Detention Center. Pointed out good fortune to have the state of the art Emergency Center in Indio - best in California
- C. Reminded us of upcoming Riverside County Fair dates an important source of income and exposure
- D. During Q&A session, residents touched on these topics:
 - a. Raise fines for illegal dumping
 - b. Large development on Dillon Road (Citrus Ranch) would tap already stressed water usage Sup Benoit talked a bit about the aquifer which is being recharged and is higher than 10 years ago though it still needs more recharging
 - c. Suggestion to light stop signs with solar powered lights and be sure they are not obscured
