

Animal Samaritans currently has a staff person assigned to work on animal rescue unitl funding for the Adoption Coordinator has been finalized. Both Rancho Mirage and Palm Desert have committed \$20,000 (\$40,000 total) to fund this position. Indian Wells committed \$1,620 for this position. It is expected that the Adoption Partner Coordinator will cost \$57,000. Animal Samaritans will enter into a memorandum of understanding with the City of Palm Desert for this position. Once this is completed Animal Samaritans will begin the hiring process.

Shelter Impounds 7/01/10 through 1/31/11:

- Unincorporated Communities (RC)- 33%
- Cathedral City- 16% (885 animals)
- Coachella- 13% (793 animals)
- Desert Hot Springs- 19% (1,121 animals)
- Indian Wells- 0.3% (20 animals)
- La Quinta- 9% (526 animals)
- Palm Desert- 7% (381 animals)
- Rancho Mirage- 3% (178 animals)

Councilmember Finerty asked the Department of Animals Services to provide the Animal Campus Commission with the Staff Report a few days prior to the meeting so the commissioners have time to review the data.
