3. COUNTY ANIMAL SERVICES (ROBERT MILLER, DIRECTOR):

The Budget Hearings will be taking place on June 15th and 16th. Robert Miller presented a Power Point presentation to the commission that included the historical background on the department, as well as the department's current state. Currently the department is facing a 4.1 million dollar budgetary shortfall that could result in the loss of city contracts as well as critical program and staff reductions. Rob also reviewed the issues and potential budget outcomes.

COUNTY ANIMAL SERVICES CONTINUED:

Rob outlined potential options for commission action as the following:

- 1. Take no action
- 2. Take action to implore the County Board of Supervisors to not allow such reductions to occur:
 - A. Such as, motion to direct the Chair to write a letter of support to the Board of Supervisors to fund requested critical and/or other department requests.
 - B. Each city, willing to do so, can or additionally write/call the Board on behalf of the budget requests on their own Council direction.
 - C. Request the Chair to speak publically at budget hearings on June 15th or 16th.
- 3. Create a separate action independent of the above

5. ANIMAL CAMPUS COMMISSION MEMBERS AND DIRECTOR COMMENTS:

Mayor Ty Peabody recommended that the commission carry out all actions as outlined by Robert Miller, and that the list be prioritized. Chairman Dana Hobart asked Robert Miller to send an email to the commission with information to include in the support letter. Fred Saunders with Animal Samaritans will be attending the Budget Hearings in support of Riverside County Department of Animal Services.
