COMMISSION MEETING MINUTES

Thursday, July 8, 2010

1. CALL TO ORDER AND ROLL CALL

The Animal Campus Commission Meeting was called to order on Thursday, July 8 at 9:37 a.m. at the Coachella Valley Association of Governments, 73-710 Fred Waring Drive, Suite 115, Palm Desert, CA by Vice Chair Kristy Franklin, Councilmember, City of La Quinta.

4. ANIMAL CAMPUS COMMISSION MEMBERS AND DIRECTOR COMMENTS

Commissioner Finerty suggested that current research shows rabies vaccinations may no longer be necessary or needed at such frequency. She is concerned that animals may be harmed, or remain unlicensed due to vaccination laws. Dr. Drusys explained there is research in progress which may alter the vaccination protocol, but results and acceptance by the scientific community are likely several more years in the future.

Commissioner Benoit introduced his new Chief of Staff, Michelle DeArmond.

5. CORRESPONDENCE

Earl Moss from the City of Cathedral City provided an authorization letter from the City to vote on behalf of the jurisdiction. (With the attendance of Mayor DeRosa, the letter was unnecessary.)

6. APPROVAL OF MINUTES

The minutes of the May 13, 2010 Animal Campus Commission Meeting were presented for approval. M/S (Baker / Spicer) to approve the May 13, 2010 meeting minutes.

7. COUNTY ANIMAL SERVICES

John Welsh explained that a new fee schedule for Animal Services will go to the Board of Supervisors for approval on July 13. It includes the new field and shelter service rates, which have increased. He also reported that local news station KMIR covered a story on the training the Animal Campus staff recently received on snakes. Adopt-a-Dog segments on television have been productive.

8. ANIMAL SAMARITANS – Fred Saunders, Executive Director

Saunders reported an increase in the number of office visits to the veterinary clinic. Two additional exam rooms are already needed, and there are four full time vets on staff. The goal of AS is to provide full services to the public at an affordable rate. He expects office hours to soon extend to 7:30 p.m.

Animal Samaritans will continue its outreach to the east valley, including pet transport for spay-neuter surgeries or vaccinations. The organization has been asked to do additional spay-neuter programs for Duroville. Pet overpopulation at the site is an ongoing problem.

The old Animal Samaritans building on Ramon Road will be renovated for shelter services and humane education. Commissioner Baker indicated the former Desert Hot Springs shelter is vacant, and could be used by another group. Saunders will investigate possibilities.

9. FRIENDS OF THE COACHELLA VALLEY ANIMAL CAMPUS

Saunders reported that he is working with Sam Esposito on the Memorial Garden. Design plans have been reduced.

10. <u>LUCY'S LAW</u>

Ms. Berman requested that the County establish a local ordinance to regulate training and certification of pet groomers. Commissioner Benoit explained that this is an issue that must go through the state legislators. He will contact Assemblyman Perez again. It was suggested that this should be brought to the attention of a statewide or national association that has lobbyists.

Commissioner Baker offered to take the information to the League of California Cities.

The discussion was tabled to the September meeting.
