

#### CALL TO ORDER AND ROLL CALL

#### 1. FINALIZATION OF AGENDA:

A correction was made to update the title for Earl Moss to Police Captain for Cathedral City.

#### 2. PUBLIC COMMENTS:

- Lindi Biggi and Janet Mcafee with "Loving All Animals" rescue group were introduced and provided a brochure for an adoption event taking place at White Water Park on November 23<sup>rd</sup> & 24<sup>th</sup> 2013. Loving All Animals encouraged all cities to submit information ASAP if that they would like to be included in the brochure for the event.
- Kim Hardee a citizen of Indio expressed her concerns in regards to helping those who have low income and are not able to spay/neuter their pets. DAS will be deploying their spay/neuter Mobile Bus as part of the Indio Contract. Also Ms. Hardee would like there to be a closer location where constituents can purchase their licenses. Mr. Miller clarified constituents can pay online or purchase a temporary license from the City.

#### 6. COUNTY ANIMAL SERVICES:

### Robert Miller, Director:

 There are errors in the Staff Report as Mr. Miller has personally been tracking the live outcome statistics. Mr. Miller said that this has been the highest number of live outcomes that he has seen since the start of his career with DAS 8 years ago. Mr. Miller gave credit to Kimberly McWhorter, Program Chief, for the numerous grants obtained that allowed DAS to deploy the Spay/Neuter Bus.

#### John Welsh, Public Information Chief:

 The department is currently participating in the Rachel Ray 100K challenge. DAS is competing amongst shelters across the US. The winning shelter will receive 100K in grant money. DAS was the number 1 contender throughout the shelter. Prior to the challenge ending they offered various adoption specials. The challenge winner will be announced September 30, 2013.

#### • Frank Corvino Deputy Director:

- There are currently no dogs left on the Schwenn property. Animal Control continues to monitor and leave food on the property.
- DAS received final estimates for the Coachella Valley Animal Campus shelter repairs and they are scheduled for the end of this year. DAS is looking into growing their volunteer program by networking with another group. Space is limited so additional space may be added in the activity yard in order to house volunteers and activities. This will be funded through o/m chargers from the City, the balance will be covered by the Department. There is enough money accumulated to accomplish a majority of the pending projects.

#### **Upcoming events:**

- October 19<sup>th</sup> Mega Match-A-Thon, Dogtoberfest, Chevy Cadillac of La Quinta will be subsidizing \$20 of the adoption price at their adoption event
- November 9<sup>th</sup>- Walk for Animals in , PetExpo
- November 23<sup>rd</sup> & 24<sup>th</sup>- Loving All Animals adoption event
- December 14<sup>th</sup> & 15<sup>th</sup>- "The River" annual adoption event

#### • Dr. Allan Drusys Chief Veterinarian:

- On October 8th the Mandatory Pit-bull sterilization ordinance will be on the board agenda. If this is adopted by the Board of Supervisors it will require that all Pit-bull breed dogs be sterilized as a condition of licensure. Zeuterin is recognized as being altered by the Department. A public hearing is anticipated to take place two weeks following the board meeting.
- The ordinance will not require that all cities adopt the ordinance it is up to each jurisdiction to adopt any part of Title VI.
- There may be funds available to assist those who cannot afford to sterilize their pet and abide by the ordinance.

#### 7. ANIMAL SAMARITANS & ADOPTION ALLIANCE UPDATE-

- Vaccination and microchip clinic will take place in Mecca on November 19, 2013. The
  County has been invited to participate. The 2<sup>nd</sup> event will be in Coachella. Animal
  Samaritans expects to have a big turnout of over 800 vaccinations. There is no official
  date but it is projected to take place in January. Animal Samaritans is currently
  expanding their services.
- Plan on expanding clinic locations. One will be in the East Valley and will go to the next board meeting for board approval.
- Have reached 4,000 animals rescued in the Adoption Alliance Program. A majority of them have come from the Coachella Valley Shelter. There are two full time staff currently working with the program. Through this program, animals are transported throughout the US.
