Desert Edge Community Council Meeting Minutes

January 9, 2024, 70200 Dillon Road, Rudolph Roo

- 1. **Call to Order:** Meeting was called to order by Dick Madison at 4:38 pm.
- 2. **Pledge of Allegiance:** Pledge of Allegiance was led by Dick Madison.
- 3. **Roll Call:** all council members were present, there was a quorum.
- 4. **Approval of the Minutes:** November 14, 2023 minutes unanimously approved without revisions.
- 5. **Councilmember Reports and Comments:** Cindy inquired about school bus stop warning signs Denis Acuna email response 2 in Desert Edge and 15 in Sky Valley, located per existing school bus stop locations established by Palm Springs Unified School District. Dick reported on grand opening with Desert Hot Springs mayor in attendance of 90-unit "tiny house" development, south of Corkill Park north of flood channel on 18th avenue discussion followed about conditional use permits and council involvement. He encouraged community members in attendance to bring others to our council meetings with recommendations to be forwarded to Supervisor Perez. Ronita asked about speed bumps on residential roads with speed limits exceeding 25 mph.

6. **Staff Reports:**

- Office of Supervisor V. Manuel Perez, Alexis Perez (760) 863-8211, AlexPerez@RIVCO.ORG. Invited all to attend 32nd Senior Inspiration Awards at Agua Caliente Casino Resort and Spa, Rancho Mirage – Sharon Huddleston former recipient. Invited participants to submit application to fill council vacancy. Announced Long Canyon road resurfacing project. Cindy asked about next Clean Up day, typically in February – flyers to be distributed via email. Crystal Craig, Assistant Executive Officer for LAFCO distributed an area map and presented options for Desert Edge incorporation as an urban place (current census designation based on resorts): 1) formation of Community Service District, possible expansion of boundaries, circulate petition, 25% required eligible voters or initiate Board of Supervisors resolution (or separate from the county (tax base) Independent Special District with five Board of Directors); 2) Create a Community Service Area, taxation and community membership with most residents seasonal and not illegible to vote addressed – 25% or registered voters to approve petition or may adopt a resolution with special study of what services will be offered (i.e., fire and police), may propose through disadvantaged communities (low or fixed income) for support/funding; and 3) Annexation with Desert Hot Springs which has funding mechanisms in place that they may implement. CSA or CSD will implement property tax on owners (Desert Crest individual parcel owners may oppose). Discussion ensued regarding hot water commercial resource for resorts and need to hook up to sewage system inside Mission Springs Water District's sphere of influence.

- C. Code Enforcement Officer Bachant reported 49 open cases for which 9 were accumulated rubbish, 2 abatement/warrant, 7 construction without permit, 1 street vending, 16 zone violations, 4 substandard structure, and 9 vehicle abatement. Closed 21 cases. Public questions regarding food vending requirements (health department issue), street racing/noise on Langlois and Corkill (Sheriff or CHP issue), roadside dumping (report license plate when

witness, document and contact CHP, \$1,000 fine), Mountain View homeless encampment (not allowed to live in RV on your own property and property owner fined if others do), Long Canyon and Dillon Road squatters and two RVs destroyed by fire (active case no comment), abandoned mobile homes (need address or general proximity to inspect), "tiny homes" new development (report online).

- D. CHP Officer Espinosa announced success of CHiPs for Kids, 10,000 toys donated and distributed at Acusure Arena, blood drive invite, and reported 18 accidents last year, 6 property damage collisions/6 injuries/6 hit and run no injuries but property damage. Requested community information on ATV accident resulting in death 12/30/23 and addressed street racing in our area.
 - E. Sherriff's Department None
- F. Emergency Management Department Joshua Holkesvig invited attendees to participate in CERT classes. Desert Edge included in damage estimates for support from Federal Emergency Management Agency; Desert Hot Springs road improvements in progress over next few months. Described Thousand Palms mobile home park recurrent flooding over Christmas weekend, requested everyone be prepared to be self-reliant and use sandbags. EMD is involved in community outreach, including earthquake preparedness. Response to question regarding CERT qualification, CERT does not require pass an exercise test, everyone is invited to training.
- G. Riverside University Health Services: Daisy Rameriz Bell addressed increase in respiratory illnesses, RSV, Covid, and encouraged vaccination. Announced mobile crisis health team and dial 988 for suicide hotline. Recent shift from communicable disease to behavioral health issues due to isolation. Provided information on where to get taxes done. Cindy inquired about AQMD's rating of 2.5 particulate matter in one month at high risk for all persons (rating for a year), contact Environmental Health.
 - H. Other Departments and Public Agencies: None
- 7. **Old Business:** Riverside County Department of Transportation Traffic Division, School Bus Accident: Representative Jesse present, Dennis Acuna attended via phone to answer specific questions. ATP (mobility plan for Desert Edge) funding approved, consultant will be on board by our next meeting. Sharon asked about the process, raising concerns about recent pedestrian death on Langlois and need for sidewalks. Consultant will begin 2/1/24 with an ad hoc group meeting in February (council members Cindy and Sharon); consultant KOA wrote grant application, report, recommendation and will make recommendations from data collected which will then be forwarded for state and other funding for other transportation and circulation projects. In the meantime, Jesse announced road works in progress on Long Canyon. Public comments addressed concerns over Varner road damage since flooding, in need of immediate repair, emergency access and alternate route from communities north of the freeway, including High Desert, when Indian and Gene Autry are closed – Sharon requested County cooperate with Cathedral City (annexation included road maintenance between Edom Hill intersection and southern end of Mountain View). Storm drainage needs survey for access to hospitals, in and out of our area.
- 8. **New Business:** None.
- 9. **Public Comments:** Dick reported Citizens on Patrol for Desert Edge initiated 12 years ago, acquired new SUV 3 years ago, is no longer active. Vehicles recalled because cannot be left off premises, must return to sheriff's Palm Desert station, require two drivers at all time, and

must patrol entire area. Suggested ATP funding finance new patrol car. Steve Daneman (Almar Acres park manager), property owner of 17 acres near Corkill on Dillon Road, described the possibility of water and sewer district, and how to develop Desert Edge, including branding. He and other park managers meeting at Sandy Cove this Saturday at 9 am. Ronita called for volunteers to apply to become a member on the council.

- 10. **Agenda Items for Next Meeting:** ATP presentation, LAFCO ad hoc committee, Citizens on Patrol update, Palm Springs Unified School District report on school bus stop locations, reroute, and signage.


